As a result, when Management receives a report, they will respond to the complaint in the Association's normal enforcement procedures, including courtesy notices, hearings, etc. Complaints will need to include identifying information such as the name of the owner and description of the dog in order to be addressed, as Management will need to know where to send letters.

More importantly, YOU are responsible for the sidewalks in front of your home. Periodically, you may want to survey the sidewalks in front of your property.



Remember, holiday lights and decorations can not be put up until after Thanksgiving, and must be removed by January 15th, 2021.

Be sure to let the Association know if you will be having guests stay over for the Holidays and need temporary parking passes.
